

Application: BOVI dehorning paste is used to dehorn calves, sheep, and goats.

The horn bud is palpable as a small colliculus at 4-6 days old calves. When the calf is fixed, cut the hair off the horn bud and its tight surrounding skin. Apply a film of BOVI dehorning paste with a supplied stick or small wood spatula to a spot over horn bud and rub it thoroughly into the bud (30-40 seconds). It is not necessary any other treatment of the calf and the process of dehorning is finished. The approximate number of calves that can be treated with one tub is 4-6. BOVI paste has prolonged effect and excellent adhesion on the skin. The old, necrotic skin peels off together with the paste residues after 10 days. The new skin is rough enough, does not bleed and cannot infect after peeling. If the paste was applied well, according to instruction, complete dehorning is as a result.

**Notice:** Keep the tried animal tied away from others and out of the rain for at least 6 hours. If it is raining and you are outside, do not apply it as the paste could run down into the calf's eyes.

Dangerous chemicals: potassium hydroxide (EC: 215-181-3).

**First aid: skin contact:** remove contaminated clothing and shoes. Wash all exposed skin area with mild soap and rinse with plenty of water. Seek medical attention. **Eye contact:** rinse immediately with plenty of water 15 minutes at least. Contact ophthalmologist immediately. **Ingestion**: rinse mouth with water. Give water to drink, max. 0,3 lit. Do not induce vomiting because of corrosive effects. Seek medical attention immediately.

**Storage and shelf life**: Keep in dry, cool, well-ventilated area, out of the reach of children. Keep tube closed when not in use. Minimize exposure to air and light. Protect from freezing. Keep at temperature not exceeding 25°C. Keep away from food, drink and animal feeding stuffs.

**Dispose** this material and its container at hazardous or special waste collection point. Dispose in a safe manner in accordance with local/national regulations.
